PROTECT THE CHILDREN

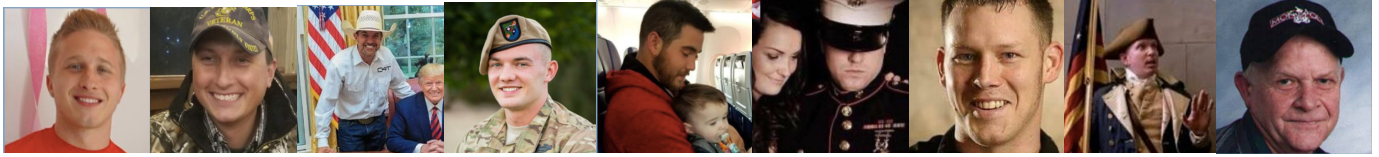

Home skills for self-sufficiency

SURVIVAL MINDSET

Your fitness for a crisis is not determined by your gear, your prep closet, or even by your physical strength. You can have all the gear in the world and still be mentally unprepared for a situation.

Navy SEALs are a good example. There have been Olympic athletes who washed out of SEAL training, while small, unassuming accountant-types make it. What's the difference? MENTAL TOUGHNESS, and anyone can have it, at any age, any level of physical ability.

Mental toughness is what keeps sidewalk counselors reaching out to women when abortion has been legal for decades. It's what Aron Ralston had, when he cut his own arm off after being trapped under a boulder for five days. It's what keeps the Jan 6 prisoners singing the National Anthem every night, when it appears the nation has abandoned them. It's what every martyr in our Church history had when they stood up for Christ.

The first ingredient of mental toughness is an unshakeable belief in your purpose. Is life worth defending? Is America worth preserving? Is the truth worth upholding? You have to *really* believe in the mission to withstand genuine hardship.

The second ingredient is the ability to trust yourself. Most often, things don't go to plan. You have to be able to make a decision quickly in changing circumstances, even a decision that affects the lives of others. In a critical situation, you may not have time to weigh all the possibilities. You have to act.

You can practice this adaptation skill in daily life by refusing to dither. If you have a decision to make, make it without procrastinating, and trust yourself to change course if needed. As Project Veritas says, "Be brave. Do something."

Mental toughness is, unfortunately, built by suffering. You can practice by undertaking difficult tasks, like adoration in the middle of the night, a long walk that goes an additional hour after you hit your comfort limit, or fasting for a day or two. Whenever you overcome your natural inclination to comfort, you are building mental toughness.

The last and most important ingredient is hope. Supernatural hope. If the storm is as bad as some fear it may be, there is going to be very little to hope in, except God and each other. And actually, that's all we ever needed to begin with! Never let go of hope. If we are here in this time, then it is because God intended us to be here; that alone is reason for hope.

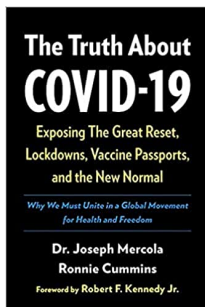
SOME DEFINITIONS

- Antigen: a substance your body doesn't recognize, and tries to fight off by means of producing antibodies against it.
- Pathogen: a disease-causing substance such as a bacterium, virus, or other microorganism
- Antibody: a protective [protein](#) produced by the [immune system](#) in response to the presence of an [antigen](#). Antibodies recognize and latch onto antigens in order to remove them from the body.
- ADE (antibody-dependent enhancement), or "pathogenic priming": the antibodies that the vaccine generates bind to the virus encountered "in the wild," and help it more easily get into cells than it would on its own. The result is often more severe illness than if the person had been unvaccinated.

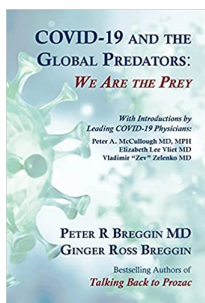

J6 Project letter to your Congressmen:

Date

Dear [Senator/Representative] _____ ,

I am writing to ask for your assistance in bringing justice to the January 6 detainees.

The citizens unjustly imprisoned, mostly in the DC Correctional Facility, in connection with January 6th need unbiased representation from *pro bono* lawyers. Their Constitutional rights to a fair, public and speedy trial have been abridged, with no outcry or protest.

DC detainees have been held in miserable conditions, in solitary confinement, where even basic needs haven't been met. They have been denied bail, and are facing harsh and completely unreasonable sentences; meanwhile they have lost jobs, homes, and families. They are at the mercy of public defenders who may be politically biased. They have been denied basic grooming and religious services. They live in grossly unsanitary conditions. Many are experiencing extreme medical neglect, with Covid-like symptoms, scurvy and other severe nutritional deficiencies, and effects of illegal beatings by guards, yet the medical personnel in the jail refuse to treat them.

THIS IS UNACCEPTABLE. These conditions are a travesty and horror to all Americans. To subject citizens to such treatment because of political bias is as low as can be.

Please don't be one of the Congressmen who have completely abandoned them. The DC detainees are virtually powerless against the threat to themselves, and to the integrity of the American rule of law. If the civil rights of one group of people can be violated, then we have all lost.

It takes courage to stand up to evil, especially when evil is considered good, and good, evil. Those from the past who were reviled for it, like Rosa Parks, Ronald Reagan and the Rev. Martin Luther King, Jr., are now considered heroes.

The abridgement of Constitutional rights and the brutal, primitive, illicit conditions under which the detainees are being held will eventually be revealed. Those who stood by and allowed this injustice will be vilified, while those willing to stand up to the evil, will be the heroes of tomorrow.

I ask you to stand on the side of truth and boldly speak up for the Constitutional rights of the January 6 detainees.

1) Children are not at risk for COVID disease

Healthy children do not die of COVID-19. They typically have zero or extremely mild symptoms, and if they are sick, then can easily be treated with the same safe medication as adults. The miniscule number of cases reported are actually children who were hospitalized for other causes, who died from their underlying conditions.

2) Children *are* at risk for vaccine injuries

In contrast, many children have tragically already been disabled or fatally damaged by the COVID vaccine, passing away of heart attacks within a few days or weeks of the shot. An unacceptably high percentage of young people who are vaccinated for COVID get myocarditis, which leaves lifelong cardiac effects and has a 5-year mortality rate of 50%, according to the Mayo Clinic.

If your child suffers an adverse effect, you are on your own. The manufacturers are exempt from any legal liability under the National Childhood Vaccine Injury Act of 1986.

3) The vaccine is not effective against COVID transmission or infection

The vaccines, including Pfizer, are not approved for human use until the trials conclude in 2023. The testing period for children aged 5-11 lasted only two months. Your children are the trial subjects. From the FDA's own literature:

*The Pfizer-BioNTech COVID-19 Vaccine is an **unapproved** vaccine that may prevent COVID-19. There is **no FDA-approved** vaccine to prevent COVID-19. The FDA has authorized the **emergency use** of the Pfizer-BioNTech COVID-19 Vaccine to prevent COVID-19 in individuals 12 years of age and older under an Emergency Use Authorization (EUA). Serious and unexpected side effects may occur. Pfizer-BioNTech COVID-19 Vaccine is **still being studied in clinical trials**.*

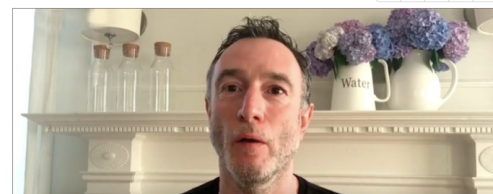

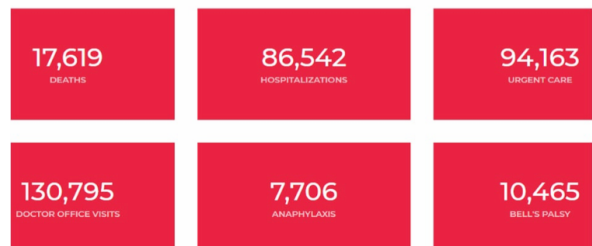

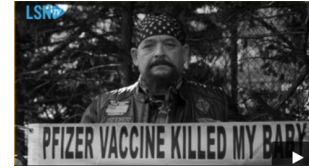

- Medium and long-term safety **data** about the COVID-19 vaccines are still lacking. Children and young people have a remaining life expectancy of 55 to 80 years.
- Vaccination policies rely on expected benefits clearly outweighing the risk of adverse events from the vaccination. The **risk-benefit analysis** for the COVID-19 vaccines points to a high potential risk versus no benefit for children and young people.
- **Transmission** of SARS-CoV-2 from children to adults is minimal and **adults** in contact with children do not have higher COVID-19 mortality. It is **unethical** to put children and young people at risk to protect adults.
- **THERE IS THUS NO MEDICAL OR PUBLIC HEALTH CASE FOR THE MASS VACCINATION OF CHILDREN AND YOUNG PEOPLE**

Protege a los niños

1) Los niños no corren riesgo de contraer la enfermedad COVID.

Los niños sanos no mueren de COVID-19. Por lo general, tienen síntomas nulos o extremadamente leves y, si están enfermos, pueden tratarse fácilmente con los mismos medicamentos seguros que los adultos. La minúscula cantidad de casos reportados son en realidad niños que fueron hospitalizados por otras causas, que murieron por sus condiciones subyacentes.



2) Los niños corren el riesgo de sufrir lesiones por vacunas.

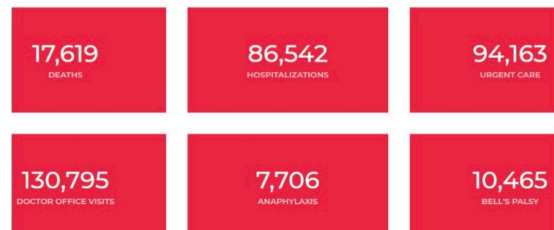

Letter to school administrators:

Dear _____,

I have been told that _____ School plans to offer COVID-19 vaccines to students this coming week. I hope the report is untrue. I am attaching a document that summarizes what scientists and doctors known to me personally have stated to be the medical problems with such a course. As the paper shows, the shot poses a serious short and long term threat to students and does them no good. It does not prevent contagion nor does it prevent transmission. Young people do not die of the disease, nor do they have serious infections. If you have been informed otherwise, these were cases of serious co-morbidities, or of students who died of something else while testing positive for Covid with the PCR test, which is being withdrawn by the FDA as of 12/31 because it can not distinguish between influenza, COVID-19 and other viruses.

Please read the attached and be informed of the risks to your students and also to you, because while the drug manufacturers have no liability, the school does retain liability for adverse events. I would add that, under Catholic teaching, a treatment that poses a serious risk to health may be undertaken only when there is no other treatment and when the benefits to the patient are proportionate to the harms. Neither circumstance applies in the case of this vaccine. We also know that any medical decision must be an informed one, so I hope you give this information to your parents.

I know you have the best interests of the children at heart.
