THE VAXXX

In this newsletter, I will refer to the various COVID injections available in the US (both the mRNA-based Pfizer and Moderna and the DNA-vectored J&J, as they all work to produce the modified spike protein) as the Vaxxx, though it is more accurate to call them “experimental genetic manipulation agents.” Truth-tellers don’t use the word “vaccine” because these experimental biological agents have not completed clinical trials, not been approved by the Food & Drug Administration and do not bear a resemblance to prior vaccines. Therefore, calling them “vaccines” confers a degree of acceptability which is not justified.

All previous approved vaccines were dead or weakened viruses injected into the subject. The virus stimulated an immune response, which remained for life, or for a very long time. The Vaxxx, on the other hand, injects genetic material which instructs cells to produce the spike protein, the “sticky” part of the SARS-CoV-2 virus that facilitates viral attachment to cells. The idea is that when the manufactured spike protein is detected, antibodies will be produced.

Problematically, the “stickiness” of the spike protein is what has been causing platelet aggregation, blood clots and inflammatory responses, all on its own, apart from the whole virus. No one knows (or is telling) how many spike proteins may be produced in the body by the Vaxxx, and what the effect might be. Further, it is not known how long the spike proteins continue to circulate in the blood, though it has already been shown to be much longer than we were told. It appears it is able to cross the blood-brain barrier which protects the central nervous system and brain.

Previous vaccines were confined to the inoculation site, and researchers have been alarmed to find that the spike proteins are circulating in the blood and accumulating in organs. The spike protein is precisely what causes blood clots, cardiovascular and neurological damage, and the variety of other serious injuries and conditions that are being reported.

UNPRECEDENTED

VAERS

The Vaccine Adverse Events Reporting System is the primary government-funded system for reporting adverse vaccine reactions in the U.S., to any vaccine. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed. (In other words, a death after the Vaxxx does not prove conclusively that the vaccine was the cause.)


Adverse effects are reported by health care providers (doctors) in a time-consuming process, and falsification carries heavy legal penalties. There are disincentives for doctors to report. The CDC is then supposed to investigate each case to determine causality, which takes several weeks to months. When you look at the numbers currently being reported in VAERS, you can imagine that the CDC is chaotically behind (confirmed by Dr. Robert Malone).

Every Friday, the CDC issues a report summarizing the reported events from the prior week. In the Jun 4 report, there were a total of 5,165 deaths reported from the COVID Vaxxx in VAERS, and a total of 295,000 adverse effects with 25,000 classified as serious injuries, *in the United States alone*. And these numbers may be low due to backlog and the reluctance of doctors to report adverse effects.

Adverse events of COVID-19 injections in the U.S. reported on June 4

A study some years ago showed that only 1 to 10% of vaccine adverse events are actually reported on VAERS. It's a voluntary system and doctors are reluctant to spend the time and possibly suffer blowback, and most vaccine consumers don't even know that VAERS exists. Using the 10% rule of thumb, there could have been 250,000 serious injuries and 50,000 deaths from the Vaxx by May 28.



Reported deaths from prior vaccines are not even in the same ballpark as the fatal fallout from the Vaxxx in 2021

Despite these staggering numbers (and they are even higher in Europe), there is a deafening silence from the media and public health agencies. During the time it took me to write this newsletter and have it reviewed, another 723 deaths were reported on VAERS, which may represent another 7,000 total fatalities. What is it going to take to shut this down?

And speaking of numbers, don't expect any truth to come out of the CDC: they are instituting a new way of counting cases so that "breakthrough" cases (people who get COVID *after* the Vaxxx, and there are many) will tend to *not* be counted, by manipulating the PCR cycle threshold. A PCR test is performed by cyclically replicating viral material to the point that it becomes detectable. By raising or lowering the number of cycles of replication, researchers can influence the probability of a positive test. Those who have not been vaccinated will continue to be counted as before, so the net effect will be that disease reporting will be maximized for the un-Vaxxed and minimized for the Vaxxed. PHASES OF CLINICAL TRIALS

For a new drug to be approved as safe and effective by the FDA, the following phases must be successfully completed:

Pre-clinical phase: testing of the drug on fetal cells or animals to determine efficacy and toxicity; multi-year
Phase I: administering various doses to healthy volunteers to determine safety; approximately 1 year
Phase II: testing of drug on participants with particular condition to assess efficacy and side effects; approximately 2 years
Phase III: testing on larger number of participants for effectiveness and safety; approximately 3 years.
Phase IV: monitoring of long-term effects

On average, it costs \$2.6 billion and takes 12-15 years to get a new drug from the lab to the pharmacy shelf. The Vaxx took less than a year, and animal safety testing was never completed. (It is significant to note that the last proposed virus for SARS-CoV-1 failed because the animals died.)

EMERGENCY USE AUTHORIZATION (EUA)

On March 13, 2020, there was a Presidential declaration of a national emergency due to COVID-19. After an emergency is declared, the FDA can issue an EUA for a new drug under these conditions:

- IF the product may be **effective** in diagnosing, treating, or preventing such disease or condition;
- IF the known and potential **benefits** of the product outweigh its known and potential **risks**; and
- IF there is no adequate, approved, and available **alternative** to the product.

IVERMECTIN

An anti-parasitic drug whose developers won the Nobel Prize for Medicine, Ivermectin is on the WHO's Model List of Essential Medicines as an anti-parasitic. Ivermectin has been in use for decades and is estimated to save 25 million lives per year from parasitic diseases which afflict about 1/3 of the world. Billions of doses have been used, it's inexpensive to produce, and has an established safety profile.

In June 2020, it was found that a single treatment of Ivermectin reduced the virus 5000-fold in 48 hours in laboratory cell cultures. After that, the race was on, and dozens of randomized controlled trials (RCT) were carried out, resulting in overwhelming evidence that Ivermectin prevented and successfully treated COVID at *all stages* of the disease.

Whole nations, primarily highly-populated developing countries, have employed Ivermectin successfully to protect their people. Meanwhile, back home in America, the FDA refuses to grant Ivermectin approval to treat COVID, though it is

approved to treat parasitic diseases. Why would the FDA grant EUA to brand-new “vaccines” without any long- or medium-term safety record, while refusing approval to Ivermectin, which is cheap, widely available and demonstrably safe?

It’s important to note that The Vaxxx could not have been cleared for EUA if an “adequate, approved alternative” were available. Ivermectin, especially in sequenced multi-drug therapies, along with nutraceuticals, is as good or better than the Vaxxx at both preventing and reducing the severity of COVID illness.

Not surprisingly, there is a news blackout on Ivermectin, with the FDA and CDC actively suppressing news that could have saved hundreds of thousands of lives. But you can get a prescription from Myfreedoctor.com or FLCCC.net if your own doctor can’t or won’t prescribe it. I used myfreedoctor.com and picked up my prescription at the pharmacy down the street from my house. I did have to answer questions as to whether I’d been exposed to COVID or had any symptoms.

NUTRACEUTICALS

A broad umbrella term for foods and food supplements that may reduce the risk of disease, improve health and extend longevity. In relation to COVID, the pertinent nutraceuticals that would be used in conjunction with Ivermectin and other medical treatments, include Vitamin D3, C, zinc in combination with quercetin, melatonin, K2, N-acetyl cysteine, and green tea extract. The quality of research varies, and you should do your own homework to decide what may work to your benefit. NATIONAL CHILDHOOD VACCINE INJURY ACT

Signed into law in 1986 in respect to the inherently risky nature of vaccines, this Act absolves manufacturers of legal liability for all vaccines.

No Vaccine manufacturer shall be liable in a civil action for damages arising from a vaccine-related injury or death associated with the administration of a vaccine after October 1, 1988, if the injury or death resulted from side effects that were unavoidable even though the vaccine was properly prepared and was accompanied by proper directions and warnings.

In the mid-1980s, seven diseases had vaccines, several of which were combined in a single shot, so that children received 5 shots by the time they were aged 2, and not more than one shot per visit. The polio vaccine was delivered orally.

Since the waiver of legal liability in 1986, the childhood vaccine schedule has increased to 63 shots. Children receive up to 27 shots by the age of 2, and up to 6 shots at a time. (www.chop.edu)

NUREMBERG CODE

After the revelation of the atrocities committed by the Nazis during World War 2 as “medical research” on prisoners, an international code was written to prevent it ever happening again. For any medical experiments, the following is essential:

- Voluntary informed consent of the subject, with no trace of coercion, fraud or deceit
- The subject must be free to bring the experiment to an end

- The scientist in charge must be ready to bring the experiment to an end if it becomes apparent that injury, disability or death is likely to result

NUREMBERG 2.0

A huge class-action lawsuit organized by German/American attorney Reiner Fuellmich and supported by thousands of attorneys and tens of thousands of physicians worldwide to prosecute those responsible for all the harm done to populations by the CDC, the WHO and world leaders manipulating the COVID situation, constituting a massive crime against humanity.

A committee investigating this possible lawsuit found that there was no excess mortality in any country (annual total death toll was same with COVID as before); doctors and hospitals were paid to declare COVID deaths; almost all fatalities had multiple co-morbidities; herd immunity is achieved when 15-25% of the population has had the infection; PCR false positives could be produced in up to 90% of cases; most lockdown protocols were illegal; the livelihoods of millions of people were destroyed; and mental health plummeted (suicide, substance abuse, domestic violence).

ANTIBODY-DEPENDENT ENHANCEMENT

Phenomenon that occurs when a virus binds to a sub-optimal antibody, which facilitates entry into cells, and then replication of the virus, exacerbating the immune response, which is capable of causing inflammation and serious organ damage. This response has been observed with previous vaccines in animal trials, most notably SARS and MERS. There is not hard evidence yet, but there is much speculation and warning: “Given past data on multiple SARS-CoV-1 and MERS-CoV vaccine efforts that have failed due to ADE in animal models, it is reasonable to hypothesize a similar ADE risk for SARS-CoV-2 antibodies and vaccines.” (Ricke, *Frontiers in Immunology*)

UNINTENDED CONSEQUENCES

Researchers published in the *International Journal of Vaccine Theory, Practice and Research* have proposed that the way in which the mRNA is modified for the vaccine approximates the “misfolding” of proteins that leads to prion diseases like encephalopathy, Parkinson’s, Alzheimer’s and ALS.

Additionally, because of the immune over-response to the engineered spike protein, healthy individuals may face chronic autoimmune disease as a consequence of excessive antibody production in response to the vaxxx, which was not necessary in the first place.

Furthermore, it has been shown that the spike protein is passed from a mother to her nursing baby in breast milk, resulting in infant deaths and failure-to-thrive. The full impact of the spike protein on infants has not been addressed, even as the Vaxxx is being tested on children down to 6 months.

“VACCINE HESITANCY”

A term that seems to have popped into widespread use overnight to refer to those who didn’t line up for experimental genetic treatment with all the enthusiasm of World Series fans at a free ticket giveaway. The NIH says that “knowledge deficit” is one of the causes of hesitancy, which is rather comical, given the amount of research we are doing about the dangers of the Vaxx. Note how they use the word “vaccine” to imply that these genetic manipulation injections are no more risky than the traditional vaccine for measles.

Government agencies are using monetary payoffs (unethical) and raffles, free beer and vaxxx stations in churches and schools to try to overcome “hesitancy.” CVS is rolling out a program for onsite vaxxing at jobsites, universities and secondary schools. ABORTION TAINT

GAIN-OF-FUNCTION RESEARCH

FERTILITY CONCERNS

When I Google'd “infertility COVID vaccine,” most of the leading articles claimed to debunk the “myth” that the Vaxxx can interfere with fertility. But how in the world could they possibly *know*, since pregnant women were *specifically excluded* from the trials? That, in itself, is alarming. Ethically, if pregnant women were not part of any of the trials, then it can't be at all okay to be giving them the Vaxxx now, with absolutely no safety data. Furthermore, no one can say that there's no damage to fertility, because we're in the middle of the experiment; it will take years to assess the damage.

Meanwhile, a report from the British MHRA showed that miscarriages in the UK increased by as much as 366 percent during the period from Dec 9, 2020 to March 7, 2021, an ominous early warning sign.

Dr. Byram Bridle, an associate professor of viral immunology at the University of Guelph in Ontario, he got access to a biodistribution study in which he found that the vaccine circulates in the bloodstream, unlike real vaccines, which are primarily confined to the inoculation site. He found concentrations of the spike proteins in the spleen and liver, and very high concentration in the ovaries. Dr. Bridle has made these findings known, with the tag, “big mistake.” (links below)

The media hid the fact that COVID is at least 99.5% survivable, and that the refrigerator trucks were empty and so were those hospital ships they parked in New York and Los Angeles Harbors. Bam, you've got focused attention, impaired peripheral awareness and increased suggestibility through fear.

The trance-like obedience is obvious everywhere. I asked one retired friend with some medical background why he had gotten the Vaxxx, and he admitted that he didn't know; he just did. RANDOMIZED CONTROLLED TRIALS

A type of medical experiment that aims to reduce bias when testing new treatments. This is accomplished by randomly assigning subjects to different groups. One group receives the treatment, while the control group gets an alternative, such as a placebo or no treatment at all. The effectiveness of the treatment is measured by comparing the two groups.

These trials are considered the "gold standard" for proving efficacy, but they are so costly and time-consuming that only large pharmaceutical companies or government agencies can finance them. If a large pharma company finances a trial at a university lab, what are the chances that the lab will deliver entirely unbiased results to the sponsoring corporation?

This scope of medical research can only reasonably be funded by large pharmaceutical companies because randomized controlled trials cost many millions of dollars. The NIH and CDC say they will only accept those "gold standard" RCTs, so the governmental agencies now practically direct research through the large pharmaceutical corporations. The pharmaceutical giants have a vested interest in expensive new drugs (like Remdesivir at \$3,000 per dose) and a vested reason to suppress inexpensive, though effective, drugs like Ivermectin. A new drug, like the Vaxxx or Remdesivir, has not yet recovered the billions of dollars it cost to develop it, so the cost is high. An older drug like Ivermectin has long since recovered its development costs, so it now sells for around \$5-16 per dose, depending on dosage.

META-ANALYSIS

Meta-analysis is a statistical technique for combining data from multiple studies on a particular topic, in order to reduce bias. If RCTs are the gold standard of evidence, meta-analyses are the platinum standard. The technique produces a stronger conclusion that can be provided by any one individual study.

As the CDC and NIH have attempted to stymie the use of Ivermectin against COVID, they have used excuses about the quality of the evidence, although it shows conclusively the effectiveness of the drug. Now Dr. Tess Lawrie in the UK has issued a peer-reviewed meta-analysis, which is a quality of evidence that cannot be easily flushed down the drain. The meta-analysis shows the effectiveness of Ivermectin in preventing infection and reducing hospitalizations and deaths, across the board. Dr. Lawrie has been imploring the British medical institutions to implement Ivermectin protocols, and "start saving lives."

BREACHES OF PROTOCOL

Biodistribution studies, tracking the way a biological agent moves through the body after injection, are standard practice in early phases of clinical trials.
